APPENDICES (sent earlier)

1. Kingston Biodiversity Partnership (KBP) meeting, KU, 12 Feb – my first opportunity to introduce TTK and our interest in nature and connectivity to the experts who could help make it happen. There were lots of familiar faces there, mainly because I've been going to Kingston Biodiversity Network meetings for years and there is some overlap + RBK officers and ClIr Ian Manders were present. The agenda was pretty full and interesting: working on the draft KBP statements on Biodiversity Net Gain (BNG) and Local Nature Recovery strategy (LNR – so many acronyms to get my head round!), mainly for local planning purposes. They certainly include wildlife corridors but needed more detail, e g on sites worth conserving, supporting arguments and data. I suggested including climate and flood resilience and RBK's climate emergency declaration. General concerns in the room included nature depletion, local housing targets, commercial dog walkers and the over-use of neonics for pet flea treatment, which not only gets into water courses, which we know, but into household dust and birds' nests (via shed or brushed pet hair) – watch recommended video of Prof Goulson's

at <u>https://www.youtube.com/watch?v=MDfg75AyyDQ&ab_channel=DaveGoulson</u>). I offered those present space in K E News if they had news or campaigns of interest or wanted volunteers or just their wildlife group listed. Next KBP meeting will be in June, probably at Tolworth Court Farm.

2. Transition Together/ London Hub meet ups:

- 28th Feb 2pm to 5pm: In person meet up in central London, National Park City London Visitor Centre, 80 Mortimer St, London W1W 7FE https://nationalparkcity.london/. MM would be going to help with a session on repairs from 5pm – 6pm, and would also attend and report back on the rest of the meeting about the outcomes of the recent Transition Assembly.

- 18th March 19:00 to 21:00 Online meet up: "For both the in-person and online sessions, the focus will be on bringing in the outcomes and connections from the Assembly. Reflecting on the London Hub journey (especially the last 1-2 years) Looking ahead together: Constitution? Organisational structure? Activities? Roles? Core group meetings? Maybe all of the above? It'll be a real working session to help us strengthen and develop our core."

3. Active travel meeting in Richmond, 11 Feb – with an encouraging talk from Will Norman, TfL's Walking & Cycling Commissioner, outlining the growth of active travel enabling infrastructure projects such as new cycle routes around London and the increasing active travel journeys resulting from these improvements and changing behaviour (both are needed). Remaining problems: borough boundaries, still too many collisions and KSIs (Killed or Seriously Injured), vociferous opposition to LTNs and 20mph limits... He encouraged active travel campaigners to contact their local councils, copying in their MPs, who have no responsibility for roads but hear a lot from drivers, and also to use opps such as Clean Air Days and funding to spread the word. Hilary was there too with KCC, so may want to elaborate. *MM*
